# 1. Call to Order and Territorial Acknowledgement

### 4. Chair's Report

No formal report.

### 4.1. SSCTL Mandate Review

There has been ongoing work to distinguish the responsibilities of the committee from that of the Teaching and Learning Commons and, upon review, the mandate was deemed to no longer accurately reflect the work done by the committee.

The following amendments were made to the proposed changes.

- Added "vocational" to #2 so that the mandate includes "qualifying, vocational, undergraduate, and graduate levels."
- Clarified the wording in #3 to clearly state that the committee recommends strategies and solutions to the Teaching and Learning Commons.
- Added "accessibility" to #5 to highlight this as a key area of focus for the committee.

The revised mandate reads:

- 1. Advice Senate on issues in teaching, learning, and related scholarship.
- 2. Advice Senate on student success Scholarship and practice at qualifying vocational, undergraduate and graduate levels of instruction.
- 3. Recommend strategies and operational solutions to the Teaching and Learning Commons that promote ongoing educational development of KPU educators across all faculties.
- 4. Receive reports and provide guidance to the operation and planning of teaching and learning events, scholarship, initiatives and environments.
- 5. Identify the forms of support needed to maintain excellence in teaching and make recommendations to Senate and other bodies as needed (such as information technology, student services, accessibility, academic integrity, etc.).
- 6. Establish other subcommittees as needed to fulfill the committee's responsibilities.
- 7. Other duties as assigned by Senate.

The revised mandate will be forwarded to the Senate Governance and Nominating Committee (SGNC) for approval.

Sharmen Lee moved THAT the Senate Standing Committee on Teaching and Learning recommend a revision to its mandate.

The motion carried.

## 4.2. SSCTL Membership Review

In the 2019/2020 academic year, the committee assigned a non-voting seat to the Director of the Learning Centres or their designate. However, since the role of the Director has been discontinued, the oversight of the Learning Centres now rests with the Associate Dean, Academic and Career Preparation.

Recognizing this change, the committee decided to reallocate the seat. They amended the motion to assign the seat to "the Dean or their designate," ensuring alignment with current Senate practice and allowing for future flexibility.

Sharmen Lee moved THAT the Senate Standing Committee on Teaching and Learning recommend replacing the non-voting member position assigned to the Director of the Learning Centres, or their designate, with a non-voting member position assigned to the Dean, Faculty of Academic and Career Preparation, or their designate.

The motion carried.

## 5. AVP, Teaching and Learning Report

Nishan Perera presented a written report on behalf of Leeann Waddington. See the agenda package.

### 6. New Business

### 6.1. Graduate Studies Update

Josephine Chan, Special Assistant to the Provost on Policy and Academic Affairs, presented the current status and future plans for graduate studies at KPU. Senate has approved an omnibus policy revision approach to guide decision-making processes. Josephine encouraged the committee to review the preliminary proposal and provide feedback, emphasizing that final decisions have not been made and more consultations are to come.

#### 6.2. Pathways Working Group Update

Christina Page updated the committee on its activities (see agenda package). There were questions from the committee about guidelines for course developers seeking the Pathway attribute. SSCC currently has guidelines in place, but the task force is still working with the Office

of the Provost, Faculty of ACP, and SSCC to create an improved process for assessing courses seeking the Pathway attribute. The Pathway Working Group expects to produce a recommendations report as it finishes up its work, expected in December 2023.

## 6.3. KPU Community Guidelines Discussion

Christina Page introduced the KPU Community Guidelines, developed by EDI Manager Trina Prince, to guide the committee's intentions and actions throughout the year.

The committee agreed to invite Trina Prince to present and discuss the guidelines in more depth in the upcoming months.

## 6.4. Generative AI and Teaching and Learning

Nishan Perera and Craig Wright from the Teaching and Learning Commons led a discussion, seeking feedback on potential needs for faculty support around generative AI.

### RECOMMENDED RESOLUTION

### **Background**

The proposed membership and mandate revision (approved by SSCTL on September 28, 2023) was presented to SGNC on October 10, 2023. SGNC is seeking further clarity about the use of the word "recommend" on Mandate Item 3 (below).

Our proposed motion to SGNC was tabled pending clarity on this question.

## **Review of September 2023 Mandate and Membership Review**

On September 28, 2023 the Senate Standing Committee on Teaching and Learning recommended the replacement of the non-voting member *Director of the Learning Centres, or designate* with a non-voting member *Dean, Faculty of Academic and Career Preparation, or designate*.

On September 28, 2023 the Senate Standing Committee on Teaching & Learning recommended the revision of the current Senate Standing Committee on Teaching and Learning mandate to:

- 1. Advise Senate on issues in teaching, learning, and related scholarship.
- 2. Advise Senate on student success scholarship and practice at the qualifying, vocational, undergraduate, and graduate levels of instruction.
- 3. Recommend strategies and operational solutions to the Teaching & Learning Commons that promote ongoing educational development of KPU educators across all Faculties.

- 4. Receive reports and provide guidance to the operation and planning of teaching and learning events, scholarship, initiatives and environments.
- 5. Identify the forms of support needed to maintain excellence in teaching and make recommendations to Senate and other bodies as needed (such as information technology, student services, accessibility, academic integrity etc.).
- 6. Establish other subcommittees as needed to fulfill the committee's responsibilities.
- 7. Other duties as assigned by Senate



## **Learning Centre Report**

The Learning Centres implemented several new resources and programs in Summer 2023, with the goal of helping to support students in developing their self-directed and independent learning skills so that they can confidently engage in learning activities that help them achieve their personal learning goals. We provide resources, one-on-one appointments as well as in-and out-of-class support. Additionally, we continue to train and manage the peer tutoring program, academic review sessions, academic skills workshops, and integrated and embedded course and program supports.



In the first pilot term, tutors completed 109 appointments at Civic Plaza.

We hope to continue to grow our support and presence on this campus as students become familiar with our availability.

# **Summer Offerings:**

Summer is a busy time for our Learning Centres as we aid in supporting incoming students for the Fall with the largest offerings of KPU 100: Introduction to University. We also offer KPU 100 Head Start for a select number of incoming student referrals from high school advisors.


#### **KPU 100:**

KPU 100 provides an interactive, supported learning experience for students to start off their university careers on the right track. They will have the opportunity to engage with Learning Strategists and other students in real-time sessions, and complete interactive learning activities at their own pace each day during this week-long program. Along the way, students receive supportive feedback and guidance as they work through short assignments that build their knowledge, skills, and confidence as a university learner. This non-credit series of modules is offered completely free to KPU students.



#### KPU 100 Head Start:

This series is an adapted version of KPU 100 used to support new KPU students who have been identified by their high schools as being 'at risk' in the transition to university. It was developed in collaboration with Academic Advisor Mike Harris, Theresa Voorsluys (Manager), Central Academic Advising, and The Learning Centres. August 2023 was the third iteration of this offering.








## **New Offerings in Summer 2023:**

New for Summer 2023, we offered a in-person cohort of KPU 100, as well as a customized KPU 100 cohort for students in the Pathways program who are beginning Undergraduate Courses in the Fall.

## KPU 100 Design:

After its initial pilot last summer, student and faculty feedback was collected to explore revisions to ensure this program met the need of incoming Design students. The Learning Centres in collaboration with the Wilson School of Design Dean and faculty members engaged in extensive revisions to provide a customized version of KPU 100. This was delivered to all the incoming Year One students in August of 2023.







### **KPU 100 Thriving:**

KPU 100 Thriving is a new version of KPU 100 designed to be more accessible in order to meet the needs of students who are interested in entering KPU through the Including All Citizens Pathway Program. Although this version of KPU 100 was designed for them, it is open to any incoming KPU student who would like a longer KPU 100 experience, with a more in-person and hands-on approach. To develop this program, Marti Alger (Learning Strategist) worked with Fiona Whittington-Walsh (Sociology instructor). They were also assisted by Jennifer Hardwick (English instructor) for two of the sessions. The concept was to include the aspects of KPU 100 and also to focus on thriving strategies, strategies that students could use to cope with some of the challenges and stresses presented by university life.

The program was offered for the first time in May of 2023, and 14 students participated. It was composed of 5 in-person sessions for students in the late afternoon, so that they could attend after their high school classes. In the sessions, students got to know each other, sign on to KPU computers and complete some exercises within the KPU 100 Moodle shell. During this program, Emily Ginter (Learning Strategist) presented a Basic Computer Literacy workshop. There was also a session on finances, facilitated by a KPU Financial Aid Officer. Several sessions offered additional support to become familiar with KPU technology and resources. Overall, the program was successful, and the students were very interested in progressing though their programs in the Fall.

### **Academic Skills Workshops:**

In addition to our support for incoming students, we also offer a variety of academic skills workshops throughout the summer to support students in a variety of programs. Types of workshops include: building effective study habits, self-care and productivity, improving your writing, science skills, business skills, planning, reading and note taking, and test taking strategies (for details see: <a href="https://www.kpu.ca/learningcentres/workshops">https://www.kpu.ca/learningcentres/workshops</a>). Each semester, new workshops are added based on demand and faculty requests. We continue to offer academic skills workshops online to reach students across campuses and those studying at home.



### Asynchronous Workshops:

Beginning in Summer 2022, TLC piloted 3 fully only, on-demand, asynchronous Academic Skills Workshops. This has now expanded to 7 offerings, and we have seen a steady increase in students successfully completing the workshops and submitting their exit survey questions.

 The 7 offerings include: Exam Preparation Strategies, Power Phrasing: Using information from Sources, Time Management Strategies, Effective Editing, Reading Texts, Work Effectively in Teams, Pushing back Against Procrastination.



• Examining growth from last semester, completion has more than doubled, despite summer traditionally being a slower time of year for academic skills workshops as there are fewer students taking courses at this time of year.

## **Returning Students Support and Development Program for International Students:**

In collaboration with International Academic Advising, the Returning Students Support and Development program was completed with another cohort of students in May 2023, to support re-enrollment in the Fall 2023 semester.

- 24 students enrolled.
- 83% completion rate including a one-on-one appointment with a Learning Strategists for custom strategy support.

### **Academic Integrity Initiatives:**



In collaboration with KPU's Academic Integrity Team, The Learning Centres have started to incorporate updated initiatives into our current support models.

#### This includes:

- Providing ongoing information in Tutor Training Community of Practice meetings with a focus on Academic Integrity and ways to support tutees
- In collaboration with KPU Librarians, incorporating basic citation information into paraphrasing focused workshops
- Streamlining the process of student appointments with Learning Strategists in response to an Academic Integrity breach

### **Student Support Appointments:**



## **Learning Strategist Appointments:**



### **ACADEMIC INTEGRITY REPORT**

## **Organizational Changes and Support**

The Academic Integrity team is now located at Civic Plaza on the 5<sup>th</sup> floor and has grown over the past few months. Anna Robinson accepted the position of Manager of Academic Integrity earlier this year and Susan Xia is now permanently in the Academic Integrity Strategist role. The team welcomed Ikjyot Rehal as the inaugural Academic Integrity Liaison in August where she will be providing support for preventing, detecting, and responding to academic integrity breaches. A large part of her role is to assist with complex academic integrity breach cases that require time and expertise to solve. In addition, two Academic Integrity Student Ambassadors, Alejandra Silvera and Sehajpreet Kaur, will be supporting the Academic Integrity team until Spring 2024. Their role is to work with fellow students and help them understand the importance of academic integrity, and guide them in making responsible choices when completing their academic work.

## **Academic Integrity Week**

KPU's second annual Academic Integrity Week was held October 16 – 20, 2023 in support of its key initiative in promoting a culture of academic integrity at KPU. The keynote address on Indigenous Academic Integrity from Keeta Gladue kicked off the week which included a host of activities for students, staff and faculty. The Academic Integrity Unit also collaborated with other departments including Teaching & Learning, the Learning Centres and the Library to put on various workshops and on-campus booths. The week culminated with a fun game of Academic Integrity Jeopardy hosted by our Academic Integrity Student Ambassadors.
