1. Call to Order

2. Approval of Agenda

4. Chair's Report

5. Vice Provost, Teaching and Learning Report

The Vice Provost, Teaching and Learning presented her report and highlighted the growth the Commons has experienced. She also reported the receipt and review of 54 applications to the Teaching, Learning, Scholarship and Research Symposium Apr 23-25th. The committee was encouraged to attend. The Carnegie Community Engagement Canadian Pilot was introduced and it was highlighted how KPU has been selected as one of sixteen universities in this initiative.

6. New Business

6.1. Definitions for Quality Teaching and Learning Environments

On February 7, 2019 the Senate Standing Committee on Teaching and Learning recommended that Senate endorse the working definitions of quality teaching, and quality learning, environments.

On February 25, 2019, Senate returned the definitions to the Senate Standing Committee on Teaching and Learning for extended consultation and discussion.

The committee discussed the possibility of having multiple definitions from different stakeholder groups, as well as the tools that would be needed to undertake this work.

A group of student visitors to the committee indicated that making information about instructors' teaching approach available to students would also be helpful.

6.3 Failure rates: How high is too high and what do we do?

The Committee discussed the importance of investigating causes of failure other than prerequisite levels (such as construct alignment), the need to compare rates to those of other institutions, the need to consider student workload as a possible cause for failure, and general issues around classroom assessment.
